BOARD POLICY AND GUIDELINES

Board Policy 443.2 Student Bus Conduct regulations are to be used as a guide for school officials, drivers, and students in determining proper behavior on school buses and protection of students riding the bus in accordance with section 121.52(2) of the state statutes. Students are expected to abide by all the rules of conduct established by the school board, district administrator or other school officials under section 120.13 (1) of the state statutes. The complete policy and bus rules can be found on the East Troy School District website at www.eastroy.k12.wi.us or you can request a printed copy from the district office.

Reminders for all families:

- ◆ Transportation may not include door to door service. Students must be ready and waiting at the location designated by the bus company.
- ◆ The ride may not arrive or return every day at the same time, please be patient.
- ◆ All pick up/drop offs must be at the same location on the same day of the week. Inconsistent drop offs and/or pickups will not be allowed.
- ◆ **Changes to the rides must be notified before 2 p.m.** This will not take effect until the next day.
- ◆ Children must behave appropriately and follow all bus rules or the ride may be stopped. If this happens, it will be your responsibility to get your child to school.
